HOW DO I KNOW MY EXACT APPEARANCE DATE?

Your appearance date is 28 days from date of citation.. It is the LAST day that is considered "on time." You may appear on or before your appearance date

WHEN CAN I TAKE CARE OF MY CITATION?

You may appear any time (during regular business hours) Monday through Thursday 8:00 AM to 3:00 PM Lunch 12:00 to 1:00

FAILURE TO APPEAR ON OR BEFORE YOUR APPEARANCE DATE Consequences of ignoring this citation:

A: A FAILURE TO APPEAR OR VIOLATE PROMISE TO APPEAR charge and a Warrant being issued for your arrest plus court cost and fees. If a warrant for your arrest is issued, you will be subject to arrest at your home, place of business or wherever you may be found.

B. A notice will be sent to the Texas Department of Public Safety for the denial of your driver's license renewal.

INABILITY TO PAY THE FINE IS NOT a reason for failing to appear.

OPTION 1 PLEAD NO CONTEST OR GUILTY & PAY IN FULL

APPEAR IN PERSON – Come to the Blooming Grove Municipal Court Office during business hours.

APPEAR BY MAIL – Submit your payment & plea by mail (not applicable to juveniles) OR pay online at www.ci.blooming-grove.tx.us , click "PAY HERE" then chose Court, then follow prompts

PLEA OPTIONS: Choose one and sign your name

Insurance Dismissals: Provide proof of policy covering the car or the driver *at the* time of citation for a dismissal with no fee required.

Registration Dismissals: A copy of a renewed registration receipt (documenting a special late penalty fee paid to the State) and a \$20 dismissal fee.

OPTION 2 PLEAD NOT GUILTY & REQUEST A PRE-TRIAL

To contest a citation and plead NOT guilty, you must request a Pre-Trial Hearing in person, or by mail, on or before your appearance date. You may retain an attorney, who should then submit a letter of representation to the Court by your appearance date. Court hearings cannot be scheduled by phone. Check the Plea box, sign your name and mail or bring to the Court. MAKE SURE YOU SEND YOUR CORRECT MAILING ADDRESS TO THE COURT.

() I enter a plea of **NOT guilty** and request a trial. This selection means that you intend to contest the charge(s) against you. Your case will be rescheduled for a Pre-trial and you will be mailed notice of when to appear for the pre-trial conference.

- You do not possess a Commercial Driver's License.

- You are not charged with speeding more than 24 miles per hour over the speed limit and the violation did not occur in a construction zone.

• You have not taken a Driving Course within the last 12 months. The following items must be submitted to the court on or before the appearance date shown on the citation to be eligible to take the course:

- 2. Court Costs of \$129.00. (in school zone \$154.00)

3. Copy of your Texas driver's license and current proof of insurance, listing you as a covered driver.

You may be eligible for DEFERRED DISPOSITION if:

- You have a current liability insurance & are listed on the policy as a driver.
- You have a valid Driver's License.
- You are at least 17 years of Age.
- You do not have a CDL license currently or at the time of offense.
- You are not currently participating in a Deferred Disposition in any court.
- You are not charged with speeding in excess of 24 mph over the limit, nor in a construction zone.

TO REQUEST IN PERSON: Bring your driver's license, proof of insurance (for policy listing you as a driver), and payment to the Court during business hours.

TO REQUEST BY MAIL: If eligible, you may request this option by providing the following three (3) items to the Municipal Court by mail.

- 1. The completed request Form below.
- 2. Deferred payment of \$312.00
- 3. A copy of your current insurance policy which list you as a driver.

Financial Hardship/Indigent

If you are financially unable to pay a fine and/or court cost in full (one payment), there are other options, such as time-payment plans and performing community service hours instead of paving the fine and court costs. In certain situations, in which a person cannot perform community service and that person is financially unable (Indigent) to pay their fine and court cost on a time payment plan the Court will hear sworn testimony and look at evidence concerning your financial situation to help you resolve this matter. In certain severe situations, the judge can reduce the fine and court costs or eliminate them completely, depending on the severity of your financial situation. Community service options have been expanded by the Texas Legislature to include: (a) attending work and job skills training; (b) a preparatory class for high school equivalency exam; and (c) service at an educational institution. Should you have any questions regarding these options, please contact the Court.

INSTRUCTION FOR JUVENILES (AGES 10 to 16)

Persons aged 10-16 must appear in person, in open Court, WITH A PARENT or legal guardian for court hearings.

To request a Compliance Dismissal: (insurance, expired registration, driver's license) a juvenile must come to the Court office WITH A PARENT or legal guardian during business hours prior to or on their appearance date.

Defendant and parent have a legal obligation to provide the court with a current address and residence in writing and to notify the Court of any change of address while the case remains active. The obligation does not end when you reach the age of 17. Failure to keep the Court informed of your current address is a Class C misdemeanor punished by a fine up to \$500 and may result in an arrest. The obligation terminates ONLY on full discharge and satisfaction of the judgment.
